AS THE ADOPTING PARTY I AGREE TO THE FOLLOWING PROVISIONS:

- 1. To keep an ID tag on the adopted animal at all times, whether inside or outside of the house, and to obtain all of the necessary licenses required by local authorities.
- 2. To provide the adopted pet with necessary inoculations/heartworm treatments at the interval advised by my veterinarian.
- 3. To have the adopted pet under my control when it is not on the confines of my property. A secured fenced area will be provided for dogs, including shelter from the elements. The adopted pet will not be tied or chained.
- 4. To always provide nutritious food and a continuous supply of clean water and kind treatment.
- 5. The adopter shall not use the animal for breeding or primarily as a guard dog and the animal may not be used for medical or other experimental purposes.
- 6. I understand that the pet covered by these adoption papers is, as far as can be determined by the Purple Power Animal Welfare Society, in good health, and that Purple Power Animal Welfare Society is not responsible for any medical fees incurred after the adoption date.
- 7. I understand that someone from the Purple Power Animal Welfare Society may call or visit my home after the adoption to ensure that the terms of this adoption agreement are being observed.

- 8. I agree that I will not declaw an adoptive cat. I understand that the Purple Power Animal Welfare Society will assist me with materials that provide assistance with alternatives to declawing if scratching becomes a problem. If I decide I cannot work with the cat and alternative methods to curb his scratching, I agree to adhere to No.15 as listed below and return the cat to an active member of the Purple Power Animal Welfare Society.
- 9. The adopter hereby accepts possession of, title to, and responsibility for the animal being adopted and agrees to release and discharge the Purple Power Animal Welfare Society forever from liability for any injury or damages to any person or property caused by the adopted animal and from any causes of action, claims, suits or demands whatsoever that may arise as a result of such injury or damages.
- 10. The adopter hereby declares that he/she is aware (a) That animals are different from human beings in their responses to human action; (b) that the actions of animals are often unpredictable. (c) that an animal's behavior may change after it leaves its foster home and accustoms itself to a home or other different environment and (d) that Purple Power Animal Welfare Society, makes no claims as to the temperament, health, or mental disposition of any animals put up for adoption.
- 11. The adopter understands that if puppy is adopted before it meets the veterinary requirement of weight and age for spay or neuter, the foster will make an appointment (** See Below) with one of PPAWS approved veterinary. The foster will be following up and the adopter will take to the appointment.
- 12. If, for any reason, Purple Power Animal Welfare Society decides to terminate this contract they can do so anytime during the first thirty days from the date of this contract and have the animal returned to their care.
- 13. I understand that any failure to perform the foregoing agreement will constitute a breach of contract. In the event of a breach of contract, I authorize the Purple Power Animal Welfare Society to reclaim both possession and ownership of the pet.
- 14. If, for any reason, in the next two years (from date of adoption), I choose to surrender the pet(s) I have adopted, I understand that I must give 3-4 weeks from date of reach out for Purple Power Animal Welfare Society to find a suitable foster.
- 15. I understand that outside of the two-year adoption period, Purple Power Animal Welfare Society is no longer responsible/required to take animal back but will do the best it can to find a foster placement if available.
