AS THE ADOPTING PARTY I AGREE TO THE FOLLOWING PROVISIONS:

1. To keep an ID on the adopted animal at all times, whether inside or outside of the house, and to obtain all of the necessary licenses required by local authorities.
2. To provide the adopted pet with necessary inoculations/heartworm treatments at the intervals advised by my veterinarian.
3. To have the adopted pet under my control when it is not on the confines of my property. A secured fenced area will be provided for dogs, including shelter from the elements. The adopted pet will not be tied or chained.
4. To provide nutritious food and a continuous supply of clean water and kind treatment at all times.
5. The adopter shall not use the animal for breeding or primarily as a guard dog and the animal may not be used for medical or other experimental purposes.
6. I understand that the pet covered by these adoption papers is, as far as can be determined by the PP, in good health, and that the PP is not responsible for any medical fees incurred after the adoption date.
7. I understand that someone from the PP may call or visit my home after the adoption to ensure that the terms of this adoption agreement are being observed.
8. I agree that I will not declaw an adoptive cat. I understand that the Purple Power Animal Welfare Society will assist me with materials that provide assistance with alternatives to declawing if scratching becomes a problem. If I decide I cannot work with the cat and alternative methods to curb his scratching, I agree to adhere to No.6 as listed above and return the cat to an active member of the Purple Power Animal Welfare Society.

9. The adopter hereby accepts possession of, title to, and responsibility for the animal being adopted and agrees to release and discharge the Purple Power Animal Welfare Society forever from liability for any injury or damages to any person or property caused by the adopted animal and from any causes of action, claims, suits or demands whatsoever that may arise as a result of such injury or damages.
10. The adopter hereby declares that he/she is aware (a) That animals are different from human beings in their responses to human action; (b) that the actions of animals are often unpredictable. (c) that an animal's behavior may change after it leaves its foster home and accustoms itself to a home or other different environment and (d) that Purple Power Animal Welfare Society, makes no claims as to the temperament, health, or mental disposition of any animals put up for adoption.
11. If, for any reason the adopted animal can no longer be cared for by the adopter PP must be contacted and the animal must be returned to PP. The adopted animal cannot be sold online or in person or given away to anyone without written approval from PP.
12. The adopter understands that if an animal is adopted before it is sterilized \$80.00 will be refunded after the adopter has this done. Written proof of sterilization must be presented within three months to receive the refund of the spay/neuter deposit unless it is medically necessary to wait.
13. If, for any reason, PP decides to terminate this contract they can do so anytime during the first thirty days from the date of this contract and have the animal returned to their care.
14. I understand that any failure to perform the foregoing agreement will constitute a breach of contract. In the event of a breach of contract, I authorize the PP to reclaim both possession and ownership of the pet.
